NEW HOUSE RULES

1. Sales of alcoholic beverages to anyone who has not attained the age of twenty-one is prohibited.
2. Alcoholic beverages may not be taken from the premises by any member or guest.
3. The sale of package liquor is prohibited.
4. Serving of alcoholic beverages to members and guests appearing drunk or disorderly is prohibited.
5. The hour of 11:00 p.m. will be observed by all members of the Lodge when present and all activities will cease at that time.
6. Vulgar and abusive language will not be allowed.
7. The bar will be closed during election hours as mandated by law
8. Non-members will not be allowed to answer the door.
9. Members may bring guests, however, a guest is welcome only three (3) times without becoming a member. Spouse of a member are exempt from guest status
10. Political or other solicitation on the Lodge premises is prohibited
11. Members and guest will not be allowed in the building without proper attire. Shirts, trousers or shorts and shoes.
12. No credit will be extended.
13. Checks may be cashed by members only. Checks may not exceed \$25.00 in any twenty-four (24) hour period and all return checks will carry a charge of not less than \$15.00 plus any charges by the bank. Also the name or Check photo is to be posted in the register area of club room. No further checks to be cashed until returned check(s) is paid.
14. Any member found guilty of fraud, deception, and/or improper use of Lodge funds, will be subject to immediate loss of club privileges and subject to charges filed by the Lodge.
15. Guest under the age of twenty-one (21) must remain with parents at all times.
16. No pets are allowed in the Lodge.
17. No one will be allowed to stay overnight in the Lodge except as deemed necessary for security purposes.

- 18. Non-members must be accompanied by a member at all times.**
- 19. Visiting brothers/sisters and guests of another lodge are allowed the second drink free.**
- 20. Members are responsible for their guests and must remain with them at all times.**
- 21. All members are responsible for enforcement of these rules under the supervision of the bartender and/or House Committee members.**
- 22. All members are responsible for real and personal property of the Lodge and damage thereto.**
- 23. All employees will be paid Bi-weekly.**
- 24. All members will be responsible for keeping the Lodge, club room, tables and surrounding area clean.**
- 25. All guests will sign the "Guest Book".**
- 26. Lodge will not be responsible for lost or stolen articles.**
- 27. The club room hours will be at the discretion of the House Committee Closing hour will be not later than 1:00 a.m. with last call made at 12:30 a.m.**
- 28. No one is allowed behind the bar without expressed consent of the bartender on duty.**
- 29. Drinks are to be served exclusively to Elks and Elks Ladies who have valid I.D. Cards.**
- 30. Doors secured by key cards will remain secure at all times.**
